



Federal Direct Graduate PLUS Loan Request Sheet 2015-2016

This form is to be completed by a graduate student who wishes to **borrow** under the Federal Direct Graduate PLUS Loan Program and serves as authorization to run a credit check. Steps to obtaining a GradPLUS loan are as follows:

- **Complete the form below and return it via fax (203) 582-4512, or mail to the address listed below.**
- **First-time Quinnipiac borrowers**, complete the GradPLUS MPN at www.studentloans.gov. You will need your FAFSA pin to "Sign In" and be sure to select "Graduate PLUS MPN"
- **If first-time Graduate PLUS borrower**, complete the mandatory Entrance Loan Counseling at www.studentloans.gov. You will need your FAFSA pin to "sign in" and be sure to select "Complete Counseling", "Entrance Loan Counseling" and select you are a Graduate student

Quinnipiac University cannot disburse the Federal Direct Graduate PLUS Loan unless the borrower has 1) completed the MPN; 2) the loan is approved by the U.S. Department of Education; 3) completed the mandatory Entrance Loan Counseling.
